TOWN OF SUPERIOR ORDINANCE NO. 0-9 SERIES 2020

AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE TOWN OF SUPERIOR REZONING THE FORMER CENTURYLINK PROPERTY FROM PUD-RAC TO OS-N, OPEN SPACE (CASE NO. RZN-2020-03)

WHEREAS, the Town of Superior (the "Applicant") purchased certain property located in the Town of Superior, generally referred to as the former CenturyLink Property and more particularly described in Exhibit A, attached hereto and incorporated herein by this reference (the "Property");

WHEREAS, the Applicant filed an application (the "Application") to rezone the Property from Planned Unit Development with Regional Activity and Employment Center Designation (PUD-RAC) to Open Space and Natural Uses (OS-N);

WHEREAS, the specific requirements for rezoning are set forth in Sections 16-7-10 through 16-7-40 of the Code;

WHEREAS, Sections 16-7-30(a) of the Code requires a public hearing and recommendation by the Planning Commission for a rezoning request;

WHEREAS, on July 7, 2020, the Planning Commission held a properly-noticed public hearing on the Application recommending approval of the Application;

WHEREAS, Section 16-7-30(a) of the Code also requires a public hearing by the Board of Trustees prior to approval of a rezoning;

WHEREAS, on July 13, 2020, the Board of Trustees held a properly-noticed public hearing on the Application; and

WHEREAS, the Board of Trustees, upon reviewing the recommendation of the Planning Commission, hearing the statements of staff and the public, and giving due consideration to the matter, finds and determines as provided below.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF SUPERIOR, COLORADO, as follows:

<u>Section 1</u>. The Board of Trustees hereby finds and determines that the Application satisfies the criteria for rezoning set forth in Sections 16-7-30 of the Code, in that the proposed rezoning furthers the goals and policies of the Comprehensive Plan and other approved plans and does not necessitate a Comprehensive Plan amendment.

<u>Section 2</u>. The Board of Trustees hereby rezones the Property from PUD-RAC to OS-N. The Town's zoning map shall be updated accordingly.

Section 3. Severability. If any article, section, paragraph, sentence, clause, or phrase of this Ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the validity or constitutionality of the remaining portions of this Ordinance. The Board of Trustees hereby declares that it would have passed this Ordinance and each part or parts hereof irrespective of the fact that any one or part or parts be declared unconstitutional or invalid.

<u>Section 4</u>. <u>Safety</u>. This Ordinance is deemed necessary for the protection of the health, welfare and safety of the community.
