## TOWN OF SUPERIOR RESOLUTION NO. R-68 SERIES 2021

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF SUPERIOR CALLING A SPECIAL ELECTION TO BE HELD ON NOVEMBER 2, 2021, IN COORDINATION WITH BOULDER COUNTY, AND SUBMITTING A SALES AND USE TAX BALLOT ISSUE TO THE REGISTERED ELECTORS OF THE TOWN AT SUCH SPECIAL ELECTION

WHEREAS, pursuant to C.R.S. § 31-10-108, the Board of Trustees may set a special election to be held at the same time as a mail ballot election being held pursuant to Article 7.5, Title 1, of the Colorado Revised Statutes;

WHEREAS, pursuant to C.R.S. § 1-41-103, local ballot issues arising under Section 20 of Article X of the Colorado constitution may appear on the ballot in odd-numbered years;

WHEREAS, the Board wishes to submit a phased-in sales and use tax ballot question to voters to seek approval of needed additional funding for transportation improvements; and

WHEREAS, Boulder County will conduct a mail ballot election pursuant to Article 7.5, Title 1, of the Colorado Revised Statutes on November 2, 2021.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF SUPERIOR, COLORADO, as follows:

Section 1. The Board of Trustees calls a special election for November 2, 2021, to be coordinated with Boulder County,

Section 2. At the Town's November 2, 2021, special election, the following ballot issue shall be submitted to the registered electors of the Town:

SHALL TOWN OF SUPERIOR TAXES BE INCREASED BY \$1,100,000 ANNUALLY IN THE FIRST FULL FISCAL YEAR (2022), AND BY ANOTHER \$500,000 ANNUALLY IN THE SECOND FISCAL YEAR (2023), AND BY WHATEVER ADDITIONAL AMOUNTS ARE COLLECTED ANNUALLY THEREAFTER, BY AN INCREASE IN THE SALES AND USE TAX RATE OF 0.28% IN 2022 AND 0.16% IN 2023, FOR A PHASED-IN SALES AND USE TAX RATE INCREASE TOTALING 0.44% OVER TWO YEARS, WITH THE REVENUES FROM SUCH TAX INCREASE TO BE USED FOR TRANSPORTATION IMPROVEMENTS; AND SHALL THE TOWN BE AUTHORIZED TO COLLECT, RETAIN, AND SPEND ALL SUCH REVENUE AND ANY INVESTMENT EARNINGS AND INTEREST

THEREON WITHOUT LIMITATION AND WITHOUT LIMITING THE EXPENDITURE OF ANY OTHER REVENUES OR FUNDS UNDER ARTICLE X, SECTION 20, OF THE COLORADO CONSTITUTION?
