**A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF SUPERIOR APPROVING THE TOWN'S PARTICIPATION IN A COORDINATED ELECTION WITH BOULDER COUNTY FOR THE TOWN'S NOVEMBER 5, 2024 REGULAR TOWN ELECTION, AND SUBMITTING BALLOT QUESTIONS TO THE TOWN'S REGISTERED ELECTORS AT SUCH ELECTION**

**Whereas**, by Ordinance No. O-14, Series 2023 and pursuant to the Municipal Home Rule Act of 1971, C.R.S. § 31-2-201, *et seq.*, as amended, the Board of Trustees initiated the process for adoption of a home rule charter;

**Whereas**, at the November 7, 2023 special Town election, the Town's registered electors approved formation of a Home Rule Charter Commission;

**Whereas**, on May 13, 2024, within 180 days after its election and as required by C.R.S. § 31-2-206(10), the Town of Superior Home Rule Charter Commission submitted to the Board of Trustees its proposed home rule charter;

**Whereas**, pursuant to C.R.S. § 31-2-207, the Town must now publish notice of the proposed charter and set the charter ballot question;

**Whereas**, pursuant to C.R.S. § 31-2-207, the Town must hold an election for consideration of adoption of the proposed home rule charter, to be held not less than 60 nor more than 185 days after publication of the notice of the proposed charter; and

**Whereas**, pursuant to C.R.S. § 1-7-116(5), the Town must notify Boulder County of its participation in a coordinated election at least 100 days before the election.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF SUPERIOR, COLORADO, as follows:**

**Section 1.** The regular Town election on November 5, 2024 shall be coordinated with Boulder County.

**Section 2.** In accordance with Article XX of the Colorado Constitution and the Municipal Home Rule Act of 1971, the following question shall be submitted to a vote of the Town's registered electors:

Shall the Town of Superior proposed home rule charter be adopted?

**Section 3.** At the coordinated election, in lieu of the Colorado Municipal Election Code of 1965, the requirements and procedures of the Uniform Election Code of 1992, Articles 1 to 13 of Title 1, C.R.S., to the extent applicable, shall apply.


**Section 4.** Pursuant to C.R.S. § 31-2-207(1), on or before June 12, 2024, the Town Clerk shall publish notice of the election. The notice of the election shall contain the full text of the proposed charter.
